Black jazz pants or black dance shorts acceptable for the Jazz & Tap Portions
only
Hair in a proper ballet bun. No hair accessories to be worn.
Bring all dance shoes with you including pointe shoes (if applicable)

Male Dancers: White v-neck t-shirt tucked in. Black full foot tights for
ballet.
Black jazz pants or black dance shorts are acceptable for the Jazz, Tap,
Contemporary, Acrobatic Portions
Bring all dance shoes with you.

All Performers: No jewelry (small earrings are fine.)

prepare. Head shots and resumes must be passed in during checkin. Please
staple resumes to headshots.

Closed Audition Process

There will be no public viewing of auditions. At checkin dancers will receive a
number. Please make sure that your child remembers or writes down their
number as it will be used for result postings. Students will audition in ballet,
jazz, tap, and acrobatics (if applicable.) Dress code must be followed to

audition. Results will be posted 1-2 weeks after the audition. An email will be sent to notify you about the result posting date.
